Township's Message - Fall 2020

2020 sure has been a trying year for everyone; I hope all the citizens, employees, business owners and anyone working in Lower Gwynedd Township remains safe and healthy. The Township remains in good financial shape in spite of the COVID-19 virus. Although some capital projects were placed on the back-burner for future considerations, many projects have started or will begin by the end of 2020.

A few items that most of you will see while walking, driving or riding bicycles through the town include:

- Route 202 project (currently underway for a 6-year project) to improve traffic patterns along the corridor. Please find PennDOT's information on this project at www.US202.com.
- Phase I of the intersection improvement at the Sumneytown Pike/Bethlehem Pike/Norristown Road/Penllyn Blue Bell Pike will begin shortly. This Phase is to widen the culvert along Sumneytown Pike down towards this intersection. This will make way for Phase II to improve that intersection for better traffic flow.
- Street Light Program to be finalized by year end 2020. All the township owned street lights will be upgraded to LED through the Regional Streetlight Procurement Program administered by the Delaware Valley Regional Planning Commission. This will improve the performance and quality of the 157 street lights in the Township with longer life expectancy and cost savings in the future.
- The Township has partnered with the MRA Group to obtain a "National Fitness Campaign and 2019 Healthy Cities Grant" which will provide an outdoor fitness court constructed on the campus of Spring House Innovation Park (SHIP) at 727 Norristown Road and open to the public. Look for information on the opening of this in November 2020.

Our current Trash Contract will expire on October 31, 2020. The Township recently went out to bid and awarded, at our September 22, 2020 Meeting, a new three-year contract to the lowest bidder, Republic Services, Inc. The new service will start on November 1, 2020. More information on billing and service will be sent out to all the customers in the Township.

LAND DEVELOPMENT & SUBDIVISION UPDATE


Below is a summary of the various land development and subdivision projects currently being reviewed, approved, or under construction within Lower Gwynedd Township at the time of this publication.

PRELIMINARY REVIEW

- **Sisters of Mercy Subdivision** (**#20-03LD**): Non-residential subdivision; Location: 1345 Sumneytown Pike; Applicant: Sisters of Mercy; Summary: 2-lot minor subdivision of a property owned by the Sisters of Mercy with the land to be conveyed to the Gwynedd Mercy Academy High School; Under review.
- Acts-Skilled Nursing Facility Building (#20-04LD): Residential development; Location: 301 Norristown Road (Gwynedd Estates);
 Applicant: ACTS; Summary: New residential 2-story skilled nursing building with 40 beds to be added to the Gwynedd Estates site; Under review.

APPROVED/UNDER CONSTRUCTION

- Foulkeways at Gwynedd-Residential "S" Unit Expansion Land Development (#19-06LD): Residential development; Location: 1120 Meetinghouse Rd.; Applicant-Foulkeways at Gwynedd; Summary: Consolidate 5 parcels and construct 4 new residential buildings that will add 7 residential living units; associated improvements including sidewalk and trail re-alignment, and stormwater management facilities; Approved 8/25/2020.
- Janssen Pharmaceutical Parking Lot Expansion Land Development (#20-01): Non-residential land development proposing three new
 parking areas, realignment of loop road and concrete walkways and the installation of associated stormwater management facilities.
 Approved 9/22/2020.
- Feller/Gleit Lot Line Change (#20-02LL): A residential lot line adjustment; Location: 1321 Gypsy Hill Rd & 811 Brushtown Rd. Approved 7/28/2020.
- Hunt Seat Associates Subdivision (#19-08SUBD): Residential Subdivision; Location: Hunt Seat Dr.; Applicant: Hunt Seat Associates LLC (Guidi Homes); Summary: 3-lot residential subdivision of a lot recently created through the Penllyn Club Subdivision (525 Gwynedd Ave Sub), applicant proposes a single-family dwelling on each lot with individual driveways taking access from Hunt Seat Dr.; Approved 6/23/2020
- **Spring House Court Subdivision** (#19-07SUBD): Residential Subdivision; Location: 1217 N. Bethlehem Pike; Applicant-Pat Sparango; Summary: 3-lot residential subdivision and land development where applicant proposes to construct three townhomes with a common private driveway and associated improvements; Approved 3/10/2020.
- 604 Dekalb Pike (#18-02LD) "Overlook at Gwynedd Valley": Residential subdivision/land development; Location-Dekalb Pike; Developer- Prospect Acquisitions; Summary- 17-unit residential townhouse development and associated improvements. Approved 9/11/18; Currently under construction
- 1325 Gypsy Hill Road Subdivision (#18-01SUBD): Residential subdivision/land development; Location-Gypsy Hill Road; Developer-DeSantis Homes; Summary- 7-Lot single-family residential subdivision/land development project on 9.5 acres off of Gypsy Hill Road; Approved 6/26/18; Currently under construction
- **1617 School House Lane** (#**18-03SUBD**): Residential subdivision; Location-School House Lane; Developer- Sal Paone; Summary- 2-lot minor residential subdivision; Approved 4/24/18; Construction on lot one has started.
- Gwynedd Walk (#17-03LD): Mixed-Use Development; Location-537-601 N. Bethlehem Pike; Developer: Pete Penna; Summary-This is a mixed-use development with a 23-unit residential townhouse community and a 7,500 square foot building for commercial/retail use; Approved 3/6/18; The project is currently under construction, tenants have moved into commercial space.
- The Carriages at Lower Gwynedd (#14-12LD): Residential Development; Location-Penllyn Pike; Developer: 4 Couzzins LLC; Summary- This is an 11-unit residential townhome development currently under construction; Approved 2/4/15; Trail connection complete

RECYCLING NEWS

Recycling is Required

Municipal and state regulations require that residents, commercial establishments and non-residential establishments recycle all recyclable materials. Commonly recycled materials include:

- Paper newspaper, office/copy paper, glossy paper, color paper, cardboard, junk mail, phone books, cereal/cracker boxes
- Plastic bottles and jugs No. 1-7
- Glass clear, green and brown containers
- Metal aluminum, steel, tin, and bimetal cans and containers

You should check with your hauler for a complete list of acceptable recyclable materials.

Are Things Really Being Recycled?

This question often comes up. People are concerned that not all of the materials they put in their recycle bin are recycled. Their concern is that some end up in landfills. This leads some to minimize their recycling efforts. According to several major waste management firms in Montgomery County, all of the acceptable recycled materials listed above are being recycled. You should continue to recycle all of the items listed above.

Things You Should Not Put into Your Recycle Bin

Here is a list of things that cannot be recycled and should not be put into your recycle bin:

- Foam containers and cups, even if they have a recycle symbol on them,
- · Cups coated with wax or plastic such as soda cups,
- Plastic bags such as grocery store bags (You can often take these bags back to the grocery store)
- Flexible packaging such as chip bags or juice pouches,
- Plastic wrap,
- Container caps,
- Diapers, yes, some people throw soiled diapers into their recycle bins.

Avoid Contamination of Recycling Materials with Food or Liquids

Materials contaminated with food or liquid cannot be recycled. Here is what you should do:

- Check that the material is recyclable. Look for the recycle symbol on items.
- Rinse jars, bottles, and cans that have visible residue in them. A quick rinse is usually adequate.
- Throw away heavily soiled items.

COVID-19 GUIDELINES

- Montgomery County events are following state guidelines and public health restrictions.
- Events may only take place during the state's green pandemic phase. Events are CANCELED if Montco is in the state's
 yellow or red phase as per state requirements.
- · Materials must be in the trunk of the car or bed of the truck.
- · If you need your gas can or container returned, please tape a note to it stating that you want to keep it.
- You must stay in your car and wear a mask while in the event site.
- · You may arrive any time within your registered appointment window.
- Please print out your ticket if possible and place it on your dashboard.
- · If you cannot attend the event, please cancel your appointment, as others may be waiting for an opening.

Take off lid, dry out paint, discard can without lid; or pour paint into plastic bag with absorbent material (clay based kitty litter, saw dust, rags) place bag and can without lid, in trash. Paint hardener can also be purchased at hardware stores.

DROP OFF GUIDELINES

- MATERIALS MUST BE IN THE TRUNK OR BED OF VEHICLE AND WILL NOT BE COLLECTED FROM PASSENGER COMPARTMENT TO MAINTAIN SOCIAL DISTANCING. The only thing in your trunk should be waste for removal.
- · Event workers will unload your materials so please remain in your vehicle with your windows up.
- BUSINESSES AND CONTRACTORS WILL BE TURNED AWAY, no commercial/industrial waste accepted.
- · Bring all substances in original containers with labels. Items must be identifiable. Do not mix materials.
- Tighten lids on all containers. If containers are leaking, pack in larger container with newspaper to soak up leaks.
- Maximum amount accepted is 25 gallons or 220 pounds. No 25- or 50-gallon drums.
- There are no permanent drop off locations in the region for household hazardous waste, only the listed collections.

STREAMBANK STABILIZATION AND IMPACTS ON STORMWATER MANAGEMENT

In 2017, Lower Gwynedd Township submitted a Pollution Reduction Plan (PRP) to the Pennsylvania Department of Environmental Protection (PADEP), which was required under the individual MS4 permit for municipalities with waterbodies that have a TMDL. After a lengthy review process the PRP received approval in 2020. One of the projects proposed in the plan is a streambank



restoration project. The project would repair eroded streambanks within the Willow Run tributary to the Wissahickon Creek. The project stream segment is located off of Old Bethlehem Pike directly behind the Lower Gwynedd Township Municipal Building. The scope of this project would include the stabilization and enhancement of approximately 300 linear feet of stream (both sides) from 100 feet upstream of the Old Bethlehem Pike bridge and 200 feet downstream.

The Wissahickon Creek suffers from what is known as the "urban creek syndrome", which means it has flashy floods, elevated concentrations of pollutants, impaired habitat and reduced species biodiversity due to suburban development. This project will re-establish and stabilize the bank and restore the area to its natural function. The project will also help control erosion in the future and protect the streambank. We also anticipate that the restoration and enhancement will reduce the amount of sediment and other pollutants from entering the stream and improve water quality throughout the watershed. This project overall seeks to improve the integrity of the streambank and protect it against erosion from flash flooding during storm events. The project will also help reduce sedimentation and nutrient loading in the Wissahickon Creek, which is an impaired waterway.

The Wissahickon Creek TMDL Assessment states that "the largest contributors of sediment are in-stream sources attributed to streambank erosion. Urbanization and paving of large areas of the watershed result in dramatic increases in stormwater runoff, which lead to periodic high flows that directly cause the erosion of streambanks, contributing silt to the shallow creek bottom. These sources are extremely difficult to pinpoint, measure, and control, but they are currently the leading cause of siltation in the Wissahickon Creek basin."

The Lower Gwynedd Township Board of Supervisors authorized staff to submit a grant application to the Pennsylvania Department of Community and Economic Development Water Restoration and Protection Program to seek funding for the streambank stabilization and enhancement project. Applications were due July 31, 2020 and grant award announcements are anticipated by year end.





New Three-Year Waste and Recycling Contract

(starting November 1, 2020 through October 31, 2023)

Year 1 - \$28.19/mo; Yeear 2 - \$29.18mo; Year 3 - \$30.20/mo

- Low Volume: \$18/mo + \$3.00 per 30-gallon Bag or tag
- Bulk Items: one (1) inclued per month; \$75 per item over one (1)
- Grass Clippings in excess of four (4) bags per picck-up: \$3.0 per bag
- Leaf and Yard Waste in excess of eight (8) bags per pick-up: \$3.00 per bag

MONTCO 20/40 GRANT AWARD

Lower Gwynedd Township was awarded the Montco 20/40 grant in the amount of \$200,000.00 for the Bethlehem Pike Pedestrian Improvement Project, which is part of an older revitalization effort that was started more than a decade ago. This effort was known as the Bethlehem Pike Beautification Project and was a comprehensive, multi-phased revitalization plan to establish Spring House as the Township's "Town Center" by transforming the pike into a walkable shopping district. Lower Gwynedd was awarded the MONTCO 20/40 Grant for a sidewalk connection project that includes the installation of two pedestrian bridges.

Specifically, the pedestrian improvements will stretch from Springwood Lane to slightly before Sheble Lane on the east side of Bethlehem Pike; and along the Spring House Woods Homeowner's Association property up to Locust Lane on the west side of Bethlehem Pike. Concrete curb and sidewalk will be installed along this corridor and will tie into existing improvements, ADA/PennDot compliant ramps will also be installed, as well as, two 40-foot span pedestrian bridges over the creek and pond. These improvements will complete a critical connection along this stretch of roadway. *We hope to begin this project in 2021.*

Driving in Flooded Waters

As if 2020 hasn't presented enough challenges for our community, heavy rains and tropical storms present another obstacle for us to overcome. While traveling your local roadways, you may encounter traffic barricades or orange safety cones blocking your route of travel. Please know that they are placed across the road with your safety in mind, and not simply to inconvenience your planned route of travel. Flooded roadways can present dangers, both easily seen as well as potentially hidden. Ignoring a closed roadway and risking the traverse could result in unnecessary catastrophe.

A flooded roadway may suddenly be covered in debris or hazards that may otherwise not be present. Rushing water may undermine the stability of a road by washing away the substructure, quickly resulting in a buckling roadway or sink holes. Even a mere six (6) inches of water may reach the undercarriage of a vehicle, rendering

it immobile if the exhaust floods. Surprisingly, many cars float in water, regardless of the condition of the tires. If you should encounter a roadway that is closed during a storm, please turn around to avoid the potential of an unnecessary emergency.

If you encounter a roadway covered in still water but can see the roadway and painted lines, drive slowly down the center of the roadway where the water will be the shallowest. Please take turns and alternate with other cars. Most important, please take your time and drive extra cautiously, no faster than 5 miles per hour. If water is rushing across the street, please DO NOT attempt to cross over moving water. Instead, don't panic, simply turn around and find an alternate route. And in the case of emergency, always remember to call 9-1-1.

All the soap, scum, and oily grit runs along the curb. Then into the storm drain and directly into our lakes, streams and into coastal waters including the Chesapeake Bay. And that causes pollution which is unhealthy for fish. So how do you avoid this whole mess? Easy. Wash your car on grass or gravel instead of the street. Or better yet, take it to a car wash where the water gets treated and recycled.

NOTES FROM THE FIRE MARSHAL—FALL 2020

Last Fall I wrote about the importance of preparing for winter by checking fireplaces and chimneys, getting fire alarm and carbon monoxide detection systems inspected and, if needed, repaired. These items remain true and deserve your attention.

This year, however, we are faced with an additional burden of COVID 19 as we look forward to going back inside to our closed spaces. Maintenance of fire systems becomes even more important, now that we are spending more time at home. We must recognize that more intensive use of anything leads to a need for more maintenance. Cleaning fans, kitchen exhausts and ovens are needed more frequently. Proper cleaning, service and maintenance also reduces false alarms or unnecessary calls to the fire companies.



Your township emergency responders—fire and EMS—have received the most updated information related to the virus. As volunteers, the firefighters are your neighbors and friends. They are dealing with the same issues and concerns, but continue to provide the emergency services when you need them. Anything you can do to help the emergency services will be greatly appreciated—remembering they are here to served our community when our community needs that help.

All of this comes back to:

- · Check and clean your chimneys and fireplaces
- Check and service your fire alarm system (this should be done annually, regardless)
- Make sure your house number is cleanly visible from the roadway (4-inch-high, ½ inch stroke numbers on contrasting background is the minimum)
- If you have a long driveway, make sure that the vegetation has been cleared to at least 12 feet wide at the roadway and with an overhead clearance of 14 feet.
- If you have contractors working in your house performing cleaning, special sanitation, painting or other tasks that create dust or mists, make sure they cover the detectors and notify your alarm company to put the system on "Test" while they are working.
- If you have a private bridge leading to your residence, it is required that the weight limit be posted at the bridge. Consult a civil or structural engineer to get this information if you have not done it. Unposted bridges are a hazard for fire apparatus and can seriously delay a fire response.

Please be safe and follow safe practices. If there is any way the Lower Gwynedd Fire Marshal's Office can be of assistance—please call the township. We are here to serve.



DOG ORDINANCE

Just a reminder that Lower Gwynedd Township has an ordinance that specifies letting dogs run loose without a leash is prohibited. All dogs must be on a leash of no more than ten feet when on streets, public grounds or property (see ordinance below). This includes all parks and ball fields.

§ 620.02 Dog regulations.

[Ord. 77. Passed 8-17-1964; Ord. 407. Passed 2-18-2003]

- (a) Dogs at Large Prohibited. [Amended 8-23-2016 by Ord. No. 509]
 - (1) As used in this Section 620.02, the term "at large" shall refer to any dog that is not restrained by the dog's owner or keeper with a least having a length of not more than 10 feet.
 - (2) It shall be unlawful for the owner or keeper of any dog, licensed or unlicensed, to permit such dog to run at large over the streets, public grounds or property, or upon the private property of anyone other than the owner or person having custody of the dog or of the property of anyone who has consented to the dog being at large on their property. The owner or keeper of the dog must be of appropriate age and discretion to properly control the actions of the dog.





MEMORIAL & COMMEMORATIVE BENCHES

Memorial and Commemorative benches are placed throughout the parks and trails. Location for new bench donations can be chosen through the Parks & Recreation Department. The engraving on the bench is of the donor's choice and must be approved by the Township. Holiday Recycling and Tree Drop off

After the Holidays have passed instead of throwing away your Tree, you can drop it off at Ingersoll Park parking lot, Wister Ave and Penllyn Pike. The Parks & Recreation Department will use the mulched trees in the Trail System.

Lower Gwynedd Township TRAIL IDENTIFICATION

This year has seen a greater use of 25 miles of trails in Lower Gwynedd Township.

We have had many people inquiring as to the white posts located on the trails. The Township in 2011 developed an identification system for the trails. All Township owned and maintained trails are marked and labeled.

The system was developed based on the trail name and then broken into numerical sections. The trail "initials" were used to identify the trails. Each section of the trail was broken down into numbered sections so that a responding service team could quickly determine the best location to access the trail. This identification system was then distributed through all the Emergency Service Departments and the Montgomery County Dispatch to be placed in their computer system so that any agency responding to an emergency could easily be directed to a location.

These posts are easily identifiable, located along the trail sections and contrast to their surroundings. The Trail Identification System can not only be used for Emergency situations but for maintenance as well. If a tree has fallen or there is a hazard, trail users can report the specific trail and section by phoning the Township. The Township also has trail head signs at the entrance to each trail section those sign indicated the Trail Name and Trail Location. Twice a year the Township staff preform an audit on the marker to ensure they have not been vandalized, damaged or removed.

Winter driving can be hazardous and scary, especially in northern regions that get a lot of snow and ice. Additional preparations can help make a trip safer, or help motorists deal with an emergency. This sheet provides safety information to your residents to help prevent motor vehicle injuries due to winter storms.

THE THREE P'S OF SAFE WINTER DRIVING:

PREPARE for the trip;
PROTECT yourself;
and PREVENT crashes on the road.

PREPARE

- Maintain Your Car: Check battery, tire tread, and windshield wipers, keep your windows clear, put no-freeze fluid in the washer reservoir, and check your antifreeze.
- Have On Hand: flashlight, jumper cables, abrasive material (sand, kitty litter, even floor mats), shovel, snow brush and ice scraper, warning devices (like flares) and blankets. For long trips, add food and water, medication and cell phone.
- Stopped or Stalled? Stay in your car, don't overexert, put bright markers on antenna or windows and shine dome light, and, if you run your car, clear exhaust pipe and run it just enough to stay warm.
- Plan Your Route: Allow plenty of time (check the weather and leave early if necessary), be familiar with the maps/ directions, and let others know your route and arrival time.

Practice Cold Weather Driving!

- During the daylight, rehearse maneuvers slowly on ice or snow in an empty lot.
- · Steer into a skid.
- Know what your brakes will do: stomp on antilock brakes, pump on non-antilock brakes.
- · Stopping distances are longer on water-covered ice and ice.
- Don't idle for a long time with the windows up or in an enclosed space.

PROTECT YOURSELF

- Buckle up and use child safety seats properly.
- · Never place a rear-facing infant seat in front of an air bag.
- · Children 12 and under are much safer in the back seat.

PREVENT CRASHES

- · Drugs and alcohol never mix with driving.
- · Slow down and increase distances between cars.
- · Keep your eyes open for pedestrians walking in the road.
- Avoid fatigue Get plenty of rest before the trip, stop at least every three hours, and rotate drivers if possible.
- If you are planning to drink, designate a sober driver.
