PURPOSE OF THIS POSITION: This is a laborer position that can perform a variety of skilled and unskilled duties related to maintaining the Township's infrastructure, facilities maintenance and repair. This position requires the applicant to perform manual labor in the maintenance and repair of Township roadways, parks, storm and sanitary sewer systems, building facilities and grounds, traffic and street lights and snow removal.

TYPICAL EXAMPLES OF WORK:

- Maintains and repairs Township roads, Township rights-of-Way, parks, storm and sanitary sewers, building facilities and grounds, traffic lights, street lights and performs snow removal
- Position requires being available for overtime and responding to emergencies when called upon
- Operate manual, pneumatic, and power maintenance tools
- Repair and maintain roads with hot asphalt and hot sealing materials
- Install street signs and traffic paint markings
- Clean and repair storm and sanitary sewers
- Salt and plow Township roadways and facilities, shovel sidewalks
- Remove trees and fallen limbs from roadways, trim back landscaping
- Cut grass in Township open spaces, trails and along Township roadways
- Operation of Township vehicles, such as dump truck, pickup truck, front end loader and tractors
- Operate public works equipment essential to the position, (shovel, broom, weed whacker, chainsaw, walk behind saw, line painting machine, etc.)

- Must maintain emergency responsiveness in the event of snow and ice, or any other weather-related emergency.
- Successful candidate must be knowledgeable in construction techniques involving street and road construction and maintenance, storm and sanitary sewer maintenance and repair, able to operate Township equipment and vehicles, including but not limited to CDL trucks, sewer jet & vacuum truck, roller, backhoe, skid steer, plate tamper, saws, pumps, compressor, generators, oil jacketed tar pot, snow removal equipment.
- This is a physically demanding position and the individual must be in good physical condition and be able to walk, crouch, climb and carry heavy objects for extended periods and be able to work in all types of weather conditions.
- The above is intended to describe the general nature and level of work being performed in this position; they are not intended to be an exhaustive list of all duties, responsibilities and qualifications of this position.

MINIMUM QUALIFICATIONS:

- Practice and maintain safe equipment operations and safety knowledge of job responsibilities by adhering to departmental, local, state and federal guidelines and laws
- Ability to understand and follow instructions
- Ability to sit and perform fine manipulation, climb, balance, stoop, kneel, crouch or crawl, occasionally
- Ability to withstand exposure to weather, vibration, high noise levels, traffic hazards and dusty conditions, occasionally
- Ability to work with moving machinery, slippery and uneven surfaces, confined spaces, and unprotected and protected heights, occasionally
- Ability to work closely with others
- Ability to be able to understand standard operating procedures and rules and regulations within the organization
- Basic knowledge of electrical, construction, landscaping, carpentry, mechanics or other related skills, preferred

NECESSARY OCCUPATIONAL TRAITS:

Basic knowledge of maintenance and construction techniques relating to roadway construction and maintenance, traffic signal and street light operation and maintenance, storm and sanitary sewers, snow removal, parkland and building maintenance and highway operations

MINIMUM EDUCATION, TRAINING, AND EXPERIENCE REQUIREMENTS:

- High School Diploma or equivalent, required
- Possession of a valid Pennsylvania Driver License with Class A Commercial

- Driver's License with Tanker Endorsement required within 6 months of hire
- Prior municipal, construction or trade experience preferred

PHYSICAL DEMANDS & WORK ENVIRONMENT
