# Master Plan:

Staff and planning committee members will meet with Gilmore & Associates on June 7<sup>th</sup> to review changes discussed at board meetings.

Kathy M. met with Pedro Geraldino at Pen Ambler Park to discuss possible locations for pickleball courts. Four or five possible locations were discussed. Later Kathy M., Sandi F., Janine M., Jamie W., and Gilmore & Associates met to discuss possible locations. Gilmore & Associates agreed to do "overlays" over possible locations to see what would work best. It is anticipated that public comment will be at the P&R board meeting in July with a final proposal presented to the BOS in the fall.

#### Mountain bike trail in Penllyn woods discussion

Representatives from both Horseways and Wissahickon Trails were on hand to voice their thoughts on the proposed bike trail. Horseways users expressed concerns about the interaction of the bicyclists with horses, even if it were only at intersecting trails. Portions where the trails overlap would bring about potentially dangerous overtaking issues.

Wissahickon Trails does not permit biking due to width and sight line issues.

It was recommended that the Township solicitor review documents pertaining to Penllyn Woods. It was also suggested to setup a meeting for the Township, Horseways, Wissahickon Trails and the Interscholastic Bike Group to meet and talk.
