- 1. Call to order. The meeting was called to order at 7 pm.
- 2. Minutes. Minutes accepted as submitted.
- 3. Request to move items from Consent Agenda to Regular agenda, and any other items to be considered as part of the Regular Agenda –
- 4. Approval of Regular Agenda. Agenda approved as is.
- 5. Consent Agenda. -nothing
- 6. Old Business BOS would like to see the budget by the end of October broken down specifically. EAC would most likely increase the tree budget (2024 increase tree giveaway to 400 trees) and also the battery and techno trash recycling. Line items budget would be best. There would be 2 lump sums, 1 for the trees and 1 for everything else. \$9048.66 has been spent to date, not including the trees. Trees cost around \$12,000 with an operating budget of \$15,000.

 - ii. Tree Giveaway Registration opens tomorrow, 9/14. Maybe we could possibly add to the bottom of the form about volunteering during the giveaway. The trees will be dropped off on Friday night. Someone from the EAC will reach out to the boy scouts for volunteer help that day.

iii. Fall Fest – Set on Saturday 9/23 will start at 9:30 am. The township will provide a table and tent for the EAC. The township employees will bring everything over to Houston Road that is needed for the EAC that day.

i. Bird walks – Steve cannot do Friday nights anymore for the bird walks, he is looking into possibly doing them on Sunday,

7. New Business -

a. Pollinator Pathway Project – We will be working on a demonstration area sometime this Fall. EAC would need to present a plan showing where in the township this could be done and what it could look like once finished. The subcommittee has identified environmental focus area that the EAC can support and provide assistance to the township.

a. Subcommittee met on 7/12 to further refine goals to tackle Watershed and Land stewardship efforts.

- c. Parks and Rec Liaison The review of the master plans and the trail connection went well but the Georgetown residents have concerns about the trail connection.
