Call to order: Kathy M. called the meeting to order at 6:04 PM.

Consideration of May 21, 2024 Meeting Minutes:

Penllyn Woods Community Building WiFi Update

Janine M. update from the Board of Supervisors:

- A Grant has acquired for Ingersoll Park fields: phase one
- A Grant has been acquired for the train station path (from Pen-Ambler park to the Penllyn train station.)

Sandi F. Update from the Recreation Director

- Progress is being made at the intersection on the old Texaco station property bringing closer the discussion about a new Lower Gwynedd digital sign.
- Recommended that board members attend the E.A.C meeting on August 14th. The EAC is planning to have a speaker come and educate them on Single use plastics.
- The township is working to develop a strategic plan for the woodlands in the Township. Staff are working with Gilmore and getting assistance from DCNR.



- This is our second year as a "tree city."
- Dog waste stations: currently number 6. The township is looking to acquire and place more:
- One at Penllyn Park
- Three at Penllyn Woods
- One at Oxford Park
- Staff will be going out with the Police to determine what bridges the new ATV will be able to cross.

Fall Fest: a change for this year will be that all the township boards and committees will share one table.

Kathy M. Comprehensive Plan Update:

Meeting took place on June 10th concerning the Bethlehem corridor.

The effort continues to make the corridor more conducive to a community friendly environment.

Kayla has been "mapping out" all the activities in the area. Through this data we hope to look for events that we can collaborate, embellish or eliminate. One thing became clear: Lower Gwynedd is effective in advertising our events to our residents.

One suggestion was to eliminate the annual egg hunt and enlist the EAC and Wissahickon trails to run a "trail day" on earth day.

Another suggestion was to observe "green Friday" on Black Friday with a tree [sapling] planning. This time of year is suitable for starting trees.
