**Approval of the minutes from March 7, 2024** – Ms. Lamar made a motion to approve the minutes, seconded by Ms. Lee. Motion passed 2-0. Ms. Martin abstained due to absence from the meeting.

# Township Solicitor Neil Stein, Esquire to discuss Sunshine Act

Neil Stein, Township Solicitor attended the HRC meeting to review the Sunshine Act. This Act requires agencies to deliberate and take official action on agency business in an open and public meeting. It requires that meetings have prior notice, and that the public can attend, participate, and comment before an agency takes that official action. The Human Relations Commission (HRC) meets these criteria. Mr. Stein reviewed the definition of a quorum and how to handle social situations when addressing committee information. Mr. Stein also reviewed the advertisement requirements for meetings and postings of agendas, as well as making amendments to an agenda during a meeting. Mr. Stein also addressed the exceptions for the Sunshine Act, which are Exec Sessions and conferences where a presentation is given. The last topic he discussed was communicating via social media, email, and text. If the communication is a group of 3 or more then that is considered a quorum, and all communication must stop until they are in a public setting. Talking one on one is fine, but all conversations via email, text or through social media would be subject to the Right to Know Law. If anyone should be in violation, then the violation could be brought to the Court of Common Pleas.

Ms. Lamar inquired about using their Lower Gwynedd email address versus creating personal emails only for HRC use. He suggested members use a personal email address dedicated to the HRC.

#### Discussion regarding update to LG Township Ordinance

Ms. Lamar asked us to table this item until the next meeting, as she would like all five members present for the discussion. Ms. Lee made a motion to table this item. Motion passed 3-0.
