Former Texaco Lot update from John F.

Soil and tree estimates are coming in at a cost that was anticipated. The first estimate on sidewalk repair has come in significantly lower than expected.
Tree removal has begun on the Dager road trail. Work is also underway to plan future tree removal projects with a work order system, thus allowing Mitch K to handle more of the planning with less involvement from Gilmore.

Sandi F. update from the recreation director

The Lower Gwynedd Little League had to go in front of the planning commission to present their proposed scoreboards at Ingersoll Park. They are looking to add sponsor panels on to the boards. Next, they will go in front of the Board of Supervisors for a Conditional Use Hearing.

Sandi F. has been involved with meetings between LGLL and Gilmore with the installation of restrooms, concession stand and press box at Ingersoll Park.

The EAC in 2025 will be altering their meetings to have a workshop format every other month to have more time dedicated to discussion to help plan. Their upcoming topic will be Single Use Plastics.

It's become apparent that people are using our parks for playing or practicing golf. A motion was made to forbid the playing and practicing golf in our parks, seconded, and carried.

Work continues on a new and improved trail map for the township.
