- i. Update Sidewalk and Trail Plan – Gilmore present: Jim and Chad  
Priority connection Map  
EAC and Planning Commission  
Safe crossings to be determined. Reviewing tributaries  
Primary corridors  
Sumneytown Pike from Tennis to Dekalb Pike

Evans Road trail starting at Gwynedd Valley Train Station planned to cross Meetinghouse Road (extend to Tanglewood) will not go to Welsh Road, as the traffic light will remain No Pedestrian.

Considerations; Trail 5' buffer off the road, 15-20 feet, close the gap near Ambler Yards. General overlapping with other committees and boards. The plan was met favorably by the P&R Committee.

ii. Update The Green (The Texaco Station)
