PARK RULES & REGULATIONS (All Parks)

1. Park Hours: No person permitted without a special permit except between sunrise and sunset.
2. Vehicles: Only in designated areas; fuel-powered recreational vehicles prohibited.
3. Alcohol & Drugs: Strictly prohibited; \$300 fine for violations.
4. Pets: Leashed only in posted areas.
5. Permits Required: Groups must have an approved permit.
6. Weapons: Hunting, firearms, bows, or other weapons prohibited.
7. Enforcement: Lower Gwynedd Township Police Department enforces all rules.
8. Permit Documentation: Permit must be in possession during use.
9. Catered Events: Certificate of insurance required.
10. Organized Sports Associations: Insurance certificate required naming Township as additional insured.
11. Fires & Grills: Prohibited.
12. Suspicious Activity: Report to Police Dept. (215) 646-5303; emergencies dial 9-1-1.
13. Waste Disposal: Trash in designated receptacles only.
14. Protection of Property: No defacing or posting of unauthorized signs.
15. Liability: Township not responsible for injuries sustained during recreational activities.

PENLLYN WOODS BUILDING RULES – DEL ROTELLE MEETING ROOM

1. Facility available 7 days/week unless scheduled for recreation activities; excludes Township holidays.
2. Users responsible for set-up and clean-up (included in reservation hours).
3. No nails, tacks, screws, staples, or attaching materials.

4. Reservations accepted from adults 21+; permit holder must be present.
5. Youth under 16 prohibited in concession area or operating appliances.
6. Permit required for all groups/parties.
7. Maximum occupancy: 40 persons.
8. Alcohol & drugs prohibited; \$300 fine for violations.
9. No smoking in building.
10. Clean-up requirements:
 - Trash in receptacles
 - Tables/chairs cleaned & returned
 - Decorations removed
 - Lights off
 - Appliances off
 - Concession equipment cleaned & returned
11. Township does not provide paper products, plasticware, or cooking utensils.
12. Permit must be on site.
13. Township may terminate events that are excessively loud or out of control.
14. Heating/air-conditioning adjustments made prior to event.
15. Report suspicious activity or vandalism to Police Dept. (215) 646-5300. For emergencies dial 9-1-1.
16. Police Department enforces all rules.
17. Township not responsible for injuries on parklands, Penllyn Woods Building, or concession areas.
18. Catered events must provide certificate of insurance.

SECURITY DEPOSIT POLICY

Security deposit refundable if:

- All equipment returned properly
- Refund issued at discretion of Recreation Director
